Are you an older adult?

- Improve your decision making ability.
- Increase your awareness of community services
- Improve your sense of well being.
- Increase your confidence in dealing with everyday problems /needs.
- Help you create a support plan.
- Take charge of and manage your situation

A support Plan describes what you want to change or improve about your life. It must clearly set out the support you want to have in place, how much it costs, and how it is managed. It will also explain why the decisions you make about your support will enable you to lead as independent and fulfilling a life as you can.

Neighbourhood watch alerts by email and street co-ordinators

Cllr Geof Welch is collating an email list to send out details of Neighbourhood watch (NHW) incidents sent to us from the Police. Social housing in the village

Whilst vacant property rarely becomes available in the village, the parish council is updating its records of people both interested and eligible for property in Littlebourne. The existing housing developments are **List Meadows and Court Meadows.** For these, there are extra requirements that need to be met for a person to be eligible to bid for a property. These requirements are set out in agreements between Littlebourne Parish Council and either Southern Housing Group or Sanctuary Housing Group. In order for an applicant to qualify for an allocation on either of these developments they must meet *one* of the following criteria:

- Currently resident in the parish of Littlebourne (including Lackenden or Lee Priory) and been so for at least 10 years
- 2. Previously been resident in the parish for a minimum of 10 years but moved away from the parish to secure affordable/appropriate accommodation.
- Is the mother or father, son or daughter, the brother of sister of a family which meets the criteria above in the first two points and whose application is evidenced by proof that continuing care to or for members of the family is necessary.
- 4. Applicants who have resided away from the parish of Littlebourne (including Lackenden and Lee Priory) for a period exceeding 20 years shall not be considered eligible unless the application meets the criteria set out in point 3 above.

If there are insufficient applicants fulfilling requirements above then nominations for housing can be considered from existing residents within the Littlebourne Parish. Preference will be given to those who have lived in Littlebourne the longest. If no one meets the Littlebourne connection criteria then applications can be considered from those residing in Ickham, Wickhambreaux, Bekesbourne and Patrixbourne but applying the same local connection criteria.

If you wish to join, or remain on the parish council waiting list for housing in Littlebourne, where special criteria applies, and you meet the above criteria, and have not yet contacted the Clerk, please do so, for an application.

Housing Needs Survey

A survey was posted to every household in Littlebourne in October 2011. Surveys were returned in pre paid envelopes to Action with Communities in Rural Kent to ensure independence. 661 surveys were distributed with 268 surveys being returned, representing a 41% response rate. The aim of the first section was to gain residents' views for new housing development in the Littlebourne area.

Littlebourne Parish Council want to ensure they can represent the community's views in responding to any proposals for new housing development. Analysis of Section 1 found that:

- 182 (67%) respondents have lived in Littlebourne parish for over 10 years.
- 203 (78%) respondents are owner occupiers.
- When asked what issues respondents would consider when looking for a new home, the most popular answer was affordability/price.
- 258 (36%) respondents indicated they would be seeking to move home in the next 3 10 years.
- The most frequently given reasons for seeking to move were due to present home being too large and retirement.
- 99 (48%) respondents wanted 2 bedrooms.
- 125 (49%) respondents would support more housing development in Littlebourne, 96 (39%) would not support development and 34 (13%) do not know.
- From respondents who would support more development, 87 (51%) said they would support infill development, 80 (47%) would support new sites.

145 (60%) respondents felt current infrastructure would not support more housing. Respondents overwhelmingly wanted a new GP surgery, then school and road improvement.

Most popular housing types favoured were homes for the elderly (94) and local needs housing (77). The second section of the survey explored shortfalls in affordable housing provision for households with local connections to Littlebourne. The majority of people in housing need wanted to rent from a housing association or shared ownership.

The largest group of people in housing need (61%) were in the age group 25 – 44.

Overall, a need for up to 26 affordable homes, for the local households was identified.

Rydon Homes

Rydon Homes met with the Chairman and Clerk on 30 January 2012. Rydon Homes have an option for development on land at the rear of The Hill / Jubilee Road, subject to planning permission being granted. Canterbury City Council is taking this site forward as one of their strategic sites.

The villagers' top priority is the provision of a new larger surgery and pharmacy. Cardys have just started ground works on the Court Hill site to keep planning permission live by establishing a material start, but there is no guaranteed funding for future rental in place. Rydon Homes agreed to talk to the doctors as a priority. Also as any development would generate more traffic there could be developer funding for road improvements, subject to Kent Highways (KHS) approval. Rydon Homes agreed to speak to KHS to find out what could be done.

Rydon Homes will now work up 2 or 3 alternative schemes., with a mix of tenure and size and type to include some bungalows, with an emphasis on the young and the elderly. Local needs housing will be split between 3-4 bedroom homes for families, and smaller accommodation. Under general policy split the development would be approximately 1/3 affordable and 2/3 market homes. Therefore, to achieve the need for 26 affordable homes (detailed in the housing needs survey) the development would need around 80 homes to be built. An agreement for the same local connection requirements as per the parish's existing schemes could be sought.

Rydon Homes will offer villagers an exhibition – one evening and a Saturday morning session – with the Clerk and/or parish council representation at a 'meet and greet' table to record registration details of who attends and to offer them a comments sheet. Please note, the presence of the parish council at the exhibition is to offer Clirs' local knowledge only – it is not a joint exhibition, nor does it assume any support for the development.
